We have several Disabled American Veterans and First Responders that reside in the San Marcos area that need our services. Many of our American Heroes live in the vicinity due to the number of military bases close by.
Do you collaborate with other organizations to achieve your mission? If so, briefly describe those partnerships highlighting any that are located in or serve San Marcos residents.	We collaborate with local rescues and shelters to obtain dogs that will potentially be service dogs. We also partner with other nonprofit organizations to share resources, ideas and events.

Our mission is to assist with the daily challenges of everyday life for Disabled American Veterans and First Responders by providing them with a Battle Buddy that is trained specifically to them to mitigate their disabilities. We train approximately 300 dogs per year, 75% of which are rescue or shelter dogs at no cost to the disabled hero. We have been chosen as California Nonprofit of the Year in 2020, recognized by several Assembly and senate people in the State of California, Nonprofit of the Year for the City of Menifee, and nationally by former President George W. Bush. We are the only Disabled Veteran and First Responder charity with a quantitative study by a major University (University of California) that our program works.

<p>Briefly describe your request for funds.</p>	<p>The Agua Hedionda Lagoon Foundation (AHLF) is seeking funding to expand access to the Academy for Environmental Stewardship (AES)—a dynamic, standards-aligned, STEAM-based outdoor education program designed for 3rd grade students across San Diego County.</p> <p>AES is delivered as a four-hour, in-person field trip to AHLF’s Discovery Campus in Carlsbad. Upon arrival, students receive a brief program orientation before being divided into small groups. Each group rotates through five interactive stations where trained educators lead hands-on, inquiry-driven lessons rooted in science and environmental literacy. The day concludes with a lively group “edutainer” session that reinforces key concepts and brings the experience full circle.</p> <p>Offered five days a week throughout the academic year (September - June), AES typically serves an entire grade per day. AHLF oversees all aspects of the program, including curriculum delivery, site logistics, and staffing—ensuring a seamless experience for schools, which are only responsible for coordinating transportation. All instructional materials, facilitation, and student supervision are provided by AHLF.</p> <p>In the 2024–2025 school year, AES served 8,526 students, nearly half (47%) attended through grant funding—making this enriching educational experience accessible to students who would not have been able to participate otherwise due to financial barriers.</p>
<p>Briefly describe the significance of your request to the San Marcos community, including anticipated numbers served.</p>	<p>This grant would specifically support schools within the San Marcos Unified School District (SMUSD) by subsidizing the cost of participation for the AES field trips. Many SMUSD schools face significant barriers to accessing high-quality, hands-on field experiences due to limited school budgets and rising transportation costs. As a result, meaningful outdoor learning opportunities—especially those focused on environmental science and place-based education—are often out of reach for these students.</p> <p>By targeting underserved schools within the district, this funding directly addresses a pressing equity gap: students living just a few miles from the Agua Hedionda Lagoon rarely have the opportunity to explore or learn about this rich and ecologically significant coastal ecosystem. The Agua Hedionda Lagoon Foundation's (AHLF) mission is to energize people through education and outreach to preserve the Agua Hedionda Lagoon as an accessible and healthy watershed. Our Vision, to be Stewards of the Watershed as we inspire future generations, so we all have access to a healthy lagoon. A safe space in nature, for all.

Founded in 1990 by a group of passionate Carlsbad citizens, AHLF has always prioritized public access, education, and conservation. In 2003, the Foundation received a generous land donation from the Kelly Family and acquired the Discovery Center—donated by the Aviara Planned Community—which now serves as our nature center, headquarters, and hub for robust environmental programming. AHLF also maintains 3.5 miles of public recreational trails surrounding the lagoon, made possible by easements granted through the California Coastal Commission.

Today, AHLF stands as a vital community hub—welcoming visitors, volunteers, students, trail users, nature lovers, families, and cultural enthusiasts. The Discovery Center is open seven days a week, free to the public, and features interactive exhibits, hands-on educational activities, and access to outdoor exploration. Our programs are inclusive and designed to support a wide range of learning styles, with the goal of sparking curiosity, increasing well-being, and encouraging environmental stewardship for all who engage with us.

Among our community offerings is the award-winning Academy for Environmental Stewardship; family festivals, educational events, and kids' camps; a summer adult lecture series; service-learning and volunteer opportunities; restoration and maintenance projects within our ecological reserve; and workforce development partnerships with the California Conservation Corps. These programs provide meaningful exposure to nature, reduce stress, and foster a sense of connection and renewal in our natural environment.

Looking ahead, AHLF has set an ambitious goal: to provide excellent environmental education to 1.3 million people over the next 10 years. This goal underscores our deep commitment to environmental literacy, sustainability, and fostering a lifelong connection to the natural world—beginning right here at the Agua Hedionda Lagoon. To achieve this, we will expand and diversify our programming to reach broader, more inclusive audiences, continue enhancing our AES programming, develop strategic partnerships, build innovative curriculum, and scale our impact without compromising quality or accessibility.

At the heart of our efforts is the AES, which aims to serve at minimum 10,000 K–12 students annually from across San Diego County. This hands-on, place-based program is designed to educate students on the history, ecology, and cultural significance of our coastal and marine environments and awaken a sense of responsibility and appreciation for the lagoon. These experiences aim to inspire the next generation of environmentalists and community leaders—individuals who will not only appreciate the natural world but work actively to protect it.

Program success is measured using two key tools. First, AHLF randomly selects 10% of student participants to complete surveys before and after their visit, assessing their baseline knowledge and attitudes. Teachers are provided with aligned pre-visit curriculum to help prepare students. At the end of the program, the same students complete a post-survey to measure growth in understanding and awareness. Second, we set clear benchmarks for success: at least 75% of students will demonstrate increased knowledge of the natural environment and conservation issues, and 100% of students will be able to describe at least one personal action they can take to help protect and conserve natural resources.

Educators consistently affirm the value and impact of our programming. One second-grade teacher from Twin Oaks Elementary shared, “I love all the hands-on activities and how students can learn relevant information related to our content.” A third-grade teacher from Richland Elementary noted, “The small groups, hands-on activities that go along with the educational content are very beneficial. I would recommend this program to others.” Another teacher from La Mirada Academy added, “I love that our kiddos get outdoors and learn about their environment.”

Through our dedicated work, collaborative partnerships, and a commitment to inclusive, impactful environmental education, AHLF continues to ensure that the Agua Hedionda Lagoon remains a place of learning, healing, and stewardship—now and for generations to come.



The Autism Society San Diego requests \$6,000 to support the delivery of a four-part educational lecture series on current topics in autism, targeted at parents, caregivers, and local professionals in the San Marcos area. Funds will cover essential costs including speaker honoraria, promotional materials to reach underserved families, refreshments for in-person attendees, workshop handouts and resources, facility rental for accessible venues, and professional Spanish interpretation services to ensure inclusivity for diverse communities. This series, spanning late winter to late spring 2026, builds on our successful programming by equipping participants with practical knowledge on self-determination, crisis preparedness, residential options, and healthcare navigation for individuals with autism. By addressing these critical areas, we aim to foster resilient families and informed communities capable of providing meaningful support.

This lecture series addresses a vital need in San Marcos, where families and professionals supporting individuals with autism often face barriers to specialized education and resources. Autism affects approximately 1 in 36 children nationwide, with similar prevalence in San Marcos, leading to challenges in daily living, healthcare access, and long-term planning for families. By offering free, accessible workshops with professional Spanish interpretation, we anticipate serving 200 participants overall, including at least 100 from San Marcos—comprising parents navigating early interventions, caregivers preparing for crises, and professionals enhancing inclusive practices. The series will empower attendees to build stronger support networks, reduce isolation, and promote community integration, ultimately creating a more inclusive San Marcos where individuals with autism can thrive and contribute fully.

Best Buddies International is a nonprofit 501(c)(3) organization dedicated to ending the social, physical, and economic isolation of the 200 million people worldwide with intellectual and developmental disabilities (IDD). Our mission is to create opportunities for one-to-one friendships, integrated employment, leadership development, inclusive living, and family support for individuals with IDD. The IDD community includes individuals with Down syndrome, autism, Fragile X, Williams syndrome, cerebral palsy, and other intellectual and developmental disabilities. Too often, people with IDD face barriers to forming social connections, pursuing leadership roles, and being fully included in schools and communities. Best Buddies works to break down these barriers by empowering individuals with and without IDD to form authentic friendships, build confidence, and create a culture of acceptance.

Social isolation remains a critical challenge for individuals with IDD. Research shows that the average person with IDD has a social circle of just three people—one of whom is often a paid caregiver—compared to an average of 125 for individuals without disabilities. This lack of connection frequently leads to loneliness and limited opportunities for social and personal growth. For students, these barriers are magnified in school settings where separate classrooms and limited opportunities for interaction often prevent inclusive friendships from forming. Without structured programs, students with IDD have fewer opportunities to build relationships with their peers. This not only impacts their quality of life but also reduces awareness, empathy, and leadership skills among students without IDD.

The Best Buddies School Friendship Program provides an intentional solution to these challenges. Through our model, students with and without IDD are matched in one-to-one friendships, supported by faculty advisors and trained student leaders. Matches commit to weekly contact and at least two monthly activities, creating opportunities for meaningful relationships to grow. Beyond individual friendships, chapters host group activities that foster a culture of inclusion across the entire school community. Currently, our Friendship Program reaches 623 individuals in San Diego County through 23 active chapters, including three elementary

schools, two middle schools, 16 high schools, and two colleges. These programs create safe spaces where students with IDD are valued, friendships are celebrated, and leadership is cultivated.

Despite this strong foundation, there remain schools and communities in San Diego County—such as San Marcos—where students with IDD do not yet have access to Best Buddies. With additional support, we aim to establish new chapters in San Marcos schools, ensuring that more students can experience the transformative impact of inclusion. Our objectives for the 2025–2026 program year include sustaining 23 active school chapters in San Diego County, establishing at least six new chapters including in San Marcos, growing chapter membership by 17%, increasing one-to-one friendship matches by 35%, supporting leadership development with 70% of chapters led by trained student volunteers, providing opportunities for at least 396 group activities across participating schools, and ensuring that 70% of chapters attend the Best Buddies Leadership Conference to foster sustainability and program excellence.

To evaluate impact, Best Buddies uses a combination of surveys, program data, and direct engagement. The Best Buddies Annual Survey captures participant feedback, while our BB360 Salesforce platform tracks one-to-one friendships and membership data. Attendance and engagement at chapter activities are monitored, and Program Managers provide oversight to ensure program effectiveness. This robust evaluation framework ensures accountability and continuous improvement.

Our achievements to date highlight the strength of this model. In San Diego County, we have established 23 school-based Friendship Chapters, serving 623 students with and without IDD. These chapters facilitate more than 350 inclusive group activities annually and empower student leaders across high schools and colleges to build sustainable inclusion programs. Most importantly, we have created spaces where students with IDD share their voices, build confidence, and take on leadership roles within their chapters and communities.

The impact of the Friendship Program is best illustrated through the voices of our participants. Frances Aguilar, Chapter President at the Academy of Our Lady of Peace, shared, “Inspired by my best friend and brother with Cerebral Palsy, I joined Best Buddies because I believe that all people—no matter ability or disability—deserve to be treated with friendship, equality, and compassion. I started a Best Buddies Chapter at my high school and continue to support the mission of inclusion because it has no limits.” Similarly, Vesna Vasich, a member of the San Diego State University chapter, described, “When I joined Best Buddies, I was given the opportunity to be myself and speak out for what I believed in. I met one of my best buddies, Addie, and we go out to eat, watch movies, and sing to our favorite songs. Addie has a special place in my heart and brings me joy. Best Buddies gave me the confidence to share my story and be a leader with Down syndrome.”

These stories reflect the transformational power of the Friendship Program—for both students with IDD who gain confidence and belonging, and their peers who learn the lifelong value of inclusion. The ultimate goal of our program is to create a world where inclusion is the norm and programs like

Best Buddies are no longer necessary. Until then, we remain committed to fostering environments where every student, regardless of ability, can belong, thrive, and lead. By expanding into San Marcos, we will take a significant step toward closing the gap in access and ensuring that all students in San Diego County have opportunities for connection, confidence, and community.

Bithiah's Family Services serves vulnerable children, youth, and families impacted by the foster care system and other hardships by providing access to food, education, mental health support, and essential resources at no cost. Our mission is to ensure that no child or family in crisis is left without the tools they need to thrive.

Our strategic objectives focus on reducing barriers to stability through three core areas: providing consistent access to food and essentials, expanding educational support for children and transitional-aged youth, and increasing access to trauma-informed mental health services. These goals are grounded in our belief that early intervention, education, and holistic support build resilience and reduce long-term risks such as homelessness, substance abuse, and academic failure.

Among our milestone achievements, we established a community resource center in San Marcos where families can access wraparound services in one place. Earlier this year, with support from the San Marcos Community Foundation, we expanded our tutoring program, which has already served more than 80 children since August. We also built a food pantry and shopping space that now anchors our nutrition education program. Parents have shared that these services ease the burden of care and the cost associated with providing high-quality essential supplies, creating a sense of stability for their families.

Together, these programs demonstrate our impact by meeting immediate needs while equipping children and families with the skills and support to achieve lasting stability.

Breast Cancer Angels (BCA) requests \$10,000 to support our "One Family at a Time" program, providing critical financial assistance to San Marcos residents undergoing breast cancer treatment. When diagnosed with breast cancer, patients often must quit their jobs to focus on healing, creating devastating financial hardship while medical bills mount.

Our program provides immediate relief through:

- Rent/mortgage assistance
- Utility payments
- Grocery gift cards
- Transportation support (gas cards, car repairs)
- Medical co-pay coverage

We typically provide \$300-\$500 monthly per family for three months during chemotherapy, with our unique hospital partnership model enabling aid delivery within one week of request—crucial for families facing imminent financial crisis. BCA's request addresses a critical gap in San Marcos' healthcare support system for cancer patients facing financial crisis. Our program will serve ~200 San Marcos residents annually, including patients and their families who are impacted by the financial devastation of a breast cancer diagnosis.

Based on our San Diego County data where we assisted 300 individuals in 2024 (distributing \$180,496) we project providing approximately \$25,000-\$30,000 in direct financial assistance to San Marcos families annually. This support prevents homelessness, food insecurity, and treatment interruptions that could prove life-threatening.

Our program's significance lies in its immediate, comprehensive impact. We serve families experiencing sudden financial crisis—not chronic poverty—helping working families who become financially vulnerable due to lost income during treatment. With our unique one-week response time through hospital partnerships, we intervene before families lose housing or utilities.

Each family receives \$300-\$500 monthly for three months, covering rent, utilities, groceries, and transportation to treatment centers. This assistance enables 50-60 additional San Marcos families to maintain stability while fighting cancer, supporting approximately 150-200 total family members including children whose well-being depends on family stability.

Founded in 2000 by Stage IV breast cancer survivor Faye Dietiker, BCA emerged from firsthand understanding of cancer's financial devastation. What began as \$2,000 to help women in Dietiker's chemotherapy room has grown into a robust organization distributing nearly \$50,000 monthly to over 150 families across Southern California.

Double Peak School seeks funding to enhance our **K–8 Innovation Program** through critical **Makerspace and Innovation Lab supplies and resources**. This program provides all students — from Transitional Kindergarten to eighth grade — opportunities to engage in **coding, robotics, engineering, circuitry, and design thinking**. Our Creating Brighter Futures for Children Project includes our Family Workshops for Separated and Divorced Families, Counseling for Children, our high conflict Cooperative Co-Parenting Program and Continue the Conversation Classes. This project offers a continuum of care for families that includes a co-parenting program for parents and children to attend together, a high conflict co-parenting program for parents to attend independently, an advanced refresher class for parent graduates and counseling services for children. The significance of our request is that, over 29 years later, we continue to honor our Founder's legacy by serving lower income families who earn less than 60% of the median income and we will never allow the cost of our programs to be a barrier to attending. In 2024, Family Workshop Scholarships were provided to 32% of San Marcos parents who were struggling financially. Without support of our Tuition Reduction Scholarships, San Marcos parents may not have access to our programs, thus their children may hold onto worries and concerns that are not theirs to hold, such as watching parental conflict and being stuck in the middle. This grant is significant to the San Marcos community because, without our programs, children are at great risk of failing in school, turning to drugs or alcohol to self-medicate, engaging in bullying behaviors or being bullied by others and/or experiencing mental health issues. With a mission of “promoting, supporting and securing the well-being of children who are experiencing family separation”, we reduce exposure to high parental conflict, domestic violence and child abuse while building resiliency and increasing self-esteem in children. KTSD exists to transform family relationships in positive ways so there is less conflict, more balance, and happier children. Our vision is that every child experiencing family separation will feel safe and secure to express their thoughts and feelings.</p> <p>As an organization with expertise in family separations, your grant will change the trajectory of a child's life course by helping them discover their own voice and by helping their parents interact in different ways. The number one theme we hear from children is that they are scared and sad when they hear their parents fighting. told us, "I have noticed that instead of my dad yelling at me to hurry up so we can do what he wants, he is asking me what I want to do to spend time together. I am less stressed and more calm." At the program graduation, Lucas' dad shared, "I learned how important our children's emotions are and how to help them navigate the changes in their family and how to listen to their feelings."

Also, the impact of family chaos seeps into school, work and community. Our project stops the momentum of this negative path and creates a journey of forgiveness, healing and overall family well-being. Fifteen-year-old Tomas attended the program with his dad. He proudly shared his graduation poster that read, "I learned that divorce is never the kids' fault." And his dad's graduation take-away was, "I learned to communicate better with my co-parent and my, OUR son, I also learned to handle conflict calmly and to always keep our child's best interest in mind. I also learned tools to build a respectful and stable family environment. We have a lot more peace in our home now. Thank you!" We impact the community because we create the space for healing and moving forward with peace in one's heart.

Our strategic objective is to bring happiness back to children who are at risk to suffer emotional difficulties that can last a lifetime; and which impact individuals and communities, as children living in high conflict families have higher incidences of academic failure, unhealthy peer relationships and addictions. The Creating Brighter Futures Project includes a continuum of care that provides opportunities for parental insight, skill building and growth, while empowering children and freeing them up from adult worries.

A milestone achievement in 2024 was when our Executive Director was awarded the Peacemaker of the Year Award by the Downtown San Diego Breakfast Rotary Club. Another achievement is that KTSD turned 29 this past June. We are planning our 30th Anniversary Celebration for June 7, 2026.

Testimonials are most observed during program graduations. For example, a 6–7-year-old Family Workshop group proudly shared this poster, "I learned to share my feelings. I learned it's okay to live in 2 homes. I learned divorce is not my fault. I learned it's ok to have a lot of feelings and they are all important." When young children learn these lessons, they feel better about themselves and their self-esteem increases, and they no longer carry the burden of their parent's behaviors or decisions, thus freeing them up to be children without adult worries.

Testimonials are also heard when a parent shares, "This program gave me a big wake-up call. My co-parent cannot meet my needs, so I can stop trying. I'm not starting the conflict anymore. Thank you!" or "My co-parent cut me from health insurance and since the divorce I have felt like a victim. I had a breakthrough this week. Using unhealthy thinking was fueling the conflict and I realized my words matter, like saying our daughter versus my daughter. She is our child, so now I am sitting in gratitude. I also realized it is empowering to take control of my reactions. I'm stronger now and I can be a positive role model. Thank you!" When parents realize high conflict is a choice and if you don't want it, you have to stop engaging, they shift towards hope. When parents learn skills to propel them forward, they experience emotional relief, are better parents and are more productive.

A grant from the San Marcos Community Foundation will ensure that children feel heard and understood and that families are given opportunities to heal, as they will have access

Our company's afterschool performing arts program, which offers both a holiday choir and a spring musical, is facing a funding shortfall for the upcoming 25/26 school year. Recent staff changes mean the school can no longer provide a helper teacher for our growing program, which now serves over 150 students. This additional staffing is essential to ensure the safety and success of our students during rehearsals and performances.

These funds would be used to hire an additional part-time teacher and to cover the rising costs of production, including sets, props, and costumes for both shows. We believe this program provides a vital artistic outlet for the students at Richland Elementary, fostering confidence and teamwork. Your contribution is critical to keeping this program thriving and growing for the students.

Our program offers two incredible opportunities for students to explore the performing arts. Our **Holiday Choir** is a popular after-school activity that brings together around 120 students. Their hard work culminates in multiple performances for both our school and the wider community. These shows reach an audience of over 300 students and an additional 300+ family and community members, spreading holiday cheer and showcasing the talent within our student body.

In the spring, our focus shifts to our **Musical Theater Performance**. This intensive program engages about 50 students who rehearse three days a week to bring a full-scale production to life. They learn all aspects of musical theater, including singing, dancing, and acting. Their captivating performances for fellow students, families, and community members are a testament to their dedication and a highlight of the school year. Both programs provide a vibrant creative outlet, fostering teamwork, confidence, and a lifelong love of the arts.

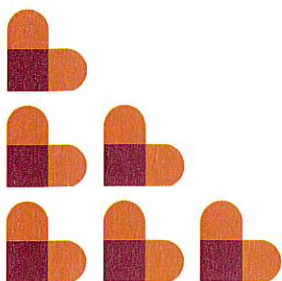

Briefly describe your request for funds.	<p>TrueCare is requesting funding to purchase an audiometer, an essential tool for conducting hearing screenings during routine primary care visits, for our San Marcos health center. This equipment allows providers to quickly and accurately identify patients who may have undiagnosed hearing loss, ensuring timely referral for further evaluation and treatment. Unmanaged hearing loss can lead to issues including decline in cognitive health and mental health and impacts on communication and relationships, as well as physical health risks like balance problems and falls.</p> <p>Currently, our health center has limited audiometers available, and because the equipment is shared across multiple providers and exam rooms, patients often experience delays and longer wait times for what should be a straightforward screening. This grant will enable us to secure a high-quality audiometer that meets the needs of our patients, ensuring timely care. Our immediate priority is to purchase one new unit for San Marcos Family Medicine, which will significantly increase patient access to hearing screenings. If awarded, a generous grant of \$1,191 would cover the cost of one Ambco Electronics 650A Audiometer, reducing bottlenecks in screenings and minimizing wait times. This model is also portable, allowing further flexibility in its use.</p>

Briefly describe the significance of your request to the San Marcos community, including anticipated numbers served.	<p>TrueCare is a 501(c)(3) Federally Qualified Health Center (FQHC) that provides culturally and linguistically appropriate, whole-person, trauma-informed health care to predominately low-income (95% below 200% federal poverty level (FPL) and 64% at or below 100% FPL), uninsured (12%), and underserved patients—those who otherwise would go without affordable care. Our mission is "to improve the health status of our diverse communities by providing quality healthcare that is comprehensive, affordable, and culturally sensitive."</p> <p>The TrueCare San Marcos health center serves over 32,000 patients annually, and of those, half seek essential primary care health services from our Family Medicine department, including regular checkups, preventive screenings, sick visits, and much more. Of note, 16.2% of San Marcos Family Medicine patients in 2024 were aged 65 years and up, and hearing loss is among the most common chronic conditions in older adults. Ensuring enough medical equipment, such audiometers, directly impacts the quality of care we provide. By funding this purchase, the grant will contribute to improved patient access and enhanced diagnostic capacity, leading to better health outcomes for families in our community. This investment supports equitable healthcare access and helps us continue delivering high-quality services to San Marcos residents who depend on our care.</p>

Since its inception in 2017, the Rising Scholars Program has served more than 750 students. In the upcoming year, we anticipate serving more than 400 individuals. Palomar Family Counseling Service (PFCS) empowers and uplifts individuals of all ages in North San Diego County by providing high-quality mental health services that foster resilience and well-being. Our strategic objectives include expanding access to trauma-informed care, building clinician expertise through ongoing training, and partnering with community entities to address mental health disparities. Since 1956, we've served over 6,000 individuals annually across prevention, early intervention, group therapy, and specialized programs like our Full Service Partnership (FSP) in San Marcos schools and Todos Los Ninos (TLN) for ages 0-5. Milestone achievements: In the last year, we reduced client wait times by 20% through school-based services and achieved 85% positive outcomes in trauma recovery, as measured by pre/post assessments. We've recently been awarded new contracts from the County of San Diego to address social-emotional needs of middle school students and funding from the San Diego Foundation to assist in addressing the behavioral health workforce shortage in San Diego County. 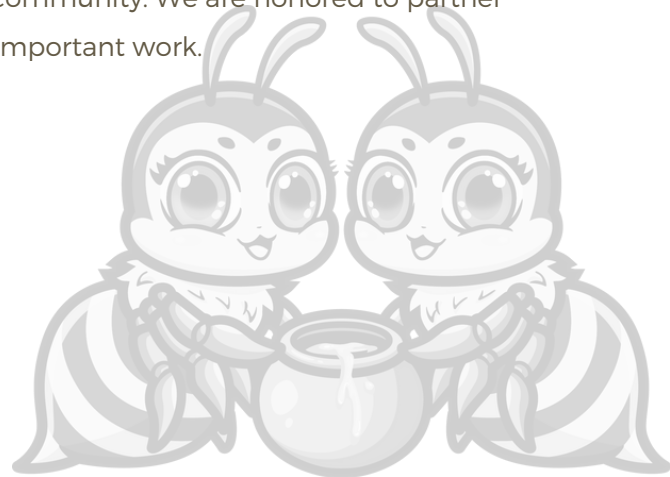

Briefly describe your request for funds.

The first phase of the Solutions program is Healing & Retreat, where new families begin their journey to self-sufficiency. The Healing and Retreat phase includes: group classes in Health & Wellness, beginning process for reunification (if involved with Child Welfare Services), connecting with peer coach and sponsor, and creating a personalized success plan. This crucial part of the program sets families up for success and is the most cost intensive portion of the 700-day program as families receive the most interactive services. Funds would be allocated towards: communal live & facilities, case management/empowerment coaching, group classes/workshops, peer support & recovery sponsorship, and therapy/counseling services.

Briefly describe the significance of your request to the San Marcos community, including anticipated numbers served.

Solutions for Change served a total 89 families in 2024, which includes 84 mothers, 20 fathers and 148 children (252 individuals). For 2025, we expect the following service outcomes:

- Up to 115 students (adults) will receive services through Solutions for Change in 2025
- 100% of the students served are low income
- Approximately 90 students will acquire and retain adequate, full-time employment
- Approximately 90 students will achieve their savings goal
- Up to 90 families will move into permanent, off-campus housing upon completion of the program

While it is difficult to pinpoint exactly where our families are 'from,' most lived along the 78 corridor—either immediately before entering Solutions or having grown up in a North County city. The impact to the San Marcos area and surrounding communities is:

- A savings of \$40,000 annually per adult (in government supportive services)
- A savings of \$54,000 annually for every child reunited with their family
- A savings of \$106,000 annually per adult not incarcerated
- Local economic growth as formerly homeless adults become employed or earn higher wages
- A reduction in crimes by and against homeless individuals

The mission of Solutions for Change is to solve family homelessness – one family, one community at a time. We offer a unique, 700-day model that blends affordable housing, educational opportunities, and employment training. Each family graduates with permanent housing, full-time employment, thousands in savings, and the knowledge needed for long-term resilience.

Our objectives are to ensure the long-term stability and self-sufficiency of the families participating in our Solutions Academy.

Objective #1: Employment - Under-employment, defined as working in low-paying or low-skilled jobs, is one of the causal factors for most homeless families. Structured classes are designed to connect residents with relevant, transferable job skills and better opportunities for adequate, long-term, stable employment.

Outcome: The outcome of objective #1 is increased employment, higher paying jobs, job retention by residents. The outcome is measured by the percentage of job success and retention by our residents.

Objective #2: Financial Stability – Only through adequate, stable, employment can our residents achieve financial stability.

Outcome: The outcome of Objective #2 is increased savings potential by our residents. The outcome is measured by the percentage of residents achieving their savings goal after 500 days in the program.



Brother Benno's serves vulnerable populations such as seniors, low-income families with children, and individuals with disabilities by preventing eviction, homelessness, and utility shutoffs. It also provides motel vouchers to homeless individuals, including those recovering from surgery, while longer-term care arrangements are made.</p> <p>However, limited resources prevent the Foundation from meeting the growing demand. Support from this funding will strengthen operations and allow the organization to reach more individuals and families in need.</p>
<p>Briefly describe the significance of your request to the San Marcos community, including anticipated numbers served.</p>	<p>Housing insecurity is rising, with more households unable to cover rent and utilities and are at greater risk of eviction. In the last fiscal year, the Brother Benno Foundation assisted 50 San Marcos households, totaling 123 residents, with \$58,687 in rental and utility aid. All assisted households were experiencing economic hardship, and 74 percent were female-headed. Research shows that female-headed households are more likely to rely on a single income, with 45 percent of mothers in the U.S. serving as primary earners and the majority being single parents (Center for American Progress, 2023). This dynamic contributes to higher rent burdens due to caregiving responsibilities and childcare costs.</p> <p>The Brother Benno Foundation also documented an increase of 14 households seeking rental assistance compared to the prior year. With additional support, the Foundation anticipates assisting at least 60 San Marcos households, approximately 140 to 150 residents, through targeted rental and utility assistance and connections to stabilizing services that prevent eviction and strengthen community well-being.</p>

In the last fiscal year, the Foundation's programs served 5,969 unique individuals, offering supports that meet immediate needs and promote long-term stability. Core programs include the Essential Services Program; the Breakfast "soup kitchen" and bag lunch program; the Showers Program; the Mail Program; the Food Recovery and Redistribution Program (Indoor Market); Supportive Services; the Scholarship Program; and the Substance Abuse Recovery Support Program.</p> <p>The Essential Services Program provides critical basics to guests experiencing homelessness, housing instability, or severe financial hardship. As available, staff distribute over-the-counter medications, personal care products, and feminine hygiene supplies. Essential Services also manages weekday bag-lunch distribution, ensuring guests receive sack lunches Monday through Friday</p> <p>The Breakfast "soup kitchen" operates from a commercial kitchen six days a week, following a scheduled menu to serve a hot, nutritious breakfast to the community. Here the recovery program volunteers assemble the daily</p>

sack lunches, which are then distributed by Essential Services.

The Food Recovery and Redistribution Program is the largest food distribution effort in North County San Diego. Rescued and donated foods are pre-sorted and quality-checked, then stocked in the Indoor Market on shelves, refrigerators, and freezers, much like a grocery store. This way guests can choose items that fit their needs, including dairy and frozen foods as available. This choice-based model supports dignity, normalcy, and balanced nutrition. Services also extend to partner nonprofits, which submit weekly pickup orders that our pantry volunteers prepare and stage for collection.

Showers are available daily, with guests receiving hygiene kits and towels to support health and dignity. The Mail Program provides a secure mailing address for individuals without housing, enabling them to receive essential documents such as birth certificates, Social Security checks, benefit notices, and letters from loved ones.

Each week, these programs distribute approximately 1,100 food boxes, 425 sack lunches, 75 packs of adult and baby diapers, 900 hot meals served six days a week, and provide an average of 74 showers to guests experiencing homelessness. These services meet essential human needs such as food, hygiene, and secure mail access. With those needs addressed, guests can begin to focus on employment, education, and rebuilding stability in their lives.

The Supportive Services Program provides vital assistance to extremely low-income households through dedicated case managers who offer rental and utility support, emergency motel vouchers, and referrals to mental-health services. In the last fiscal year, the program helped 399 households avoid evictions and utility shutoffs thus preventing homelessness. That stability let families focus on work, health, and long-term goals. To strengthen this safety net, Brother Benno's partners with a specialized homeless-services team of county social workers, benefits specialists, and additional case managers to deliver comprehensive wraparound care. In the past six months, the program adopted the HMIS Clarity database, enrolling 240 individuals and as result housed 6.

The Brother Benno Foundation also operates a volunteer-led scholarship program to support long-term transformation through education. Each year, it awards 80 scholarships of \$500 to students enrolled in the Extended Opportunity Programs and Services (EOPS) at MiraCosta and Palomar Colleges. These scholarships are granted to students who have demonstrated resilience in the face of significant life challenges, including homelessness, foster care, and substance use recovery. In addition to financial support, the program affirms the Foundation's belief in the potential of every individual to create a better future through education and perseverance.

The Substance Abuse Recovery Program offers a no cost, six-month residential recovery model grounded in the 12 step approach. Participants receive room and board, necessities, and daily recovery support. Four Certified Alcohol and Drug Counselors (CADCs) provide individualized guidance and oversight, while participants contribute volunteer service at

the Foundation's center as part of their recovery journey. This service fosters a strong work ethic, personal accountability, and a sense of community that reinforces recovery. The program also provides participants with a solid foundation in 12 step principles, instilling the tools and discipline necessary for lasting sobriety. Upon graduation, every participant is employed, housed, and eligible to reside in one of four sober living residences for up to 52 weeks, ensuring a stable transition into independent living and long-term success.

Additionally, through a valued partnership with TrueCare Mobile Health Services, a mobile medical and dental clinic visits the Foundation twice each week. Staffed by licensed healthcare professionals, the clinic provides essential medical and dental care to homeless Guests, many of whom have gone years without access to these basic services.

The Brother Benno Foundation remains a vital lifeline for the most vulnerable members of the community. With continued support, the organization can sustain and expand these essential programs, meet growing demand, and ensure that no one in need is turned away.

While our on-campus Future Centers provide year-round mentoring, skill-building, and smaller onsite events, it is the offsite experiences that give students the networks and real-world exposure needed to make informed post-graduation decisions.</p> <p>Each year, about 500 students participate in these events, with at least half coming from Twin Oaks, San Marcos, or Mission Hills High Schools. We prioritize those facing the greatest barriers to post-graduation success—students who would not otherwise have these opportunities. Offsite experiences expose students to career and postsecondary pathways they may have never considered, equip them with the knowledge to make informed choices, and connect them with local employers and training programs offering jobs, apprenticeships, and skill-building opportunities.</p> <p>By providing reliable transportation, we remove a critical barrier and ensure equitable participation. 2024/25 Impact on Students and San Marcos Community

We continued to help high school students identify and pursue their best path after graduation and equip them with the tools, confidence, and connections they need to succeed in the real world. Through our on-campus Future Centers, students gained direct access to career exploration, skill-building, professional mentorship, and postsecondary planning support. Whether they chose college, vocational training, the military, or direct entry into the workforce, we helped them take meaningful steps toward their goals.

Future Center Services: Our three SMUSD Future Centers welcomed students 4,209 times this year. Career Coaches provided 1,006 personalized coaching sessions to 719 unduplicated non-program students, covering topics such as resume development, career research, job preparation, college applications, and completion of the SuperStrong Interest Assessment. These individualized sessions reflect our commitment to meeting students where they are and helping them move forward with clarity, confidence, and a plan.

"I'm grateful for everything Project Next has done for me. They believe in me, invest in me, and help me take real steps toward my dream. I will carry this gratitude with me every single day as I move forward and get closer to becoming the nurse I've always wanted to be."

Future Center Events: Students participated in 57 Future Center events, generating over 1,250 student touchpoints (total instances of participation, including repeat attendance) and engaging hundreds of professionals. SMUSD highlights include:

- 15 Adulting workshops on life skills, goal-setting, and planning for life after high school
- 9 Career Chats featuring professionals from diverse industries
- 10 Career Nextpedition events, connecting students with professionals through immersive company visits.
- A large-scale Connect to Careers event serving 79 SMUSD students with support from 150 professionals representing 30 companies
- 11 Money Matters workshops

- Interview Skills Day workshops at each campus

"I liked that I was able to connect with different people in different careers and found out about other career choices I might look into. The professionals gave great insight and helped me feel more confident about my future."

Future Center Programs: Our two flagship programs—Focused Futures and Xcelerate—provided targeted support to students furthest from opportunity, helping them explore, prepare for, and pursue meaningful postsecondary and career pathways aligned with their individual goals.

Focused Futures served 74 SMUSD students. Students received foundational support through interest assessments, career exploration, one-on-one coaching, resume development, and participation in skill-building events. Over two-thirds of all participants already have a post-graduation plan, with 68% planning for higher education or training. 75% of seniors enrolled in community college or trade/technical school before graduation. We will continue to support students through their junior and senior years as they refine their goals and take meaningful steps toward achieving them.

"Before I found the Future Center, I didn't really think college was for someone like me. But being here, having people actually listen and help me figure things out—it made me believe in myself. Now I know I want to help other kids like me see what's possible too."

Xcelerate enrolled 55 SMUSD students, primarily seniors, who were not on a college track and lacked a defined post-graduation plan. Forty-seven actively participated in the program. Through personalized coaching, skill-building, and exposure to real-world career pathways, 46 of the actively participating students identified their best post-graduation plan. The majority of active participants created resumes, explored career opportunities, and connected with employers and training programs to broaden their awareness of options. By graduation, nearly half of these students applied to community college, 17% to trade or technical school, 4% to a 4-year college, 4% to an apprenticeship, 9% enlisted in the military, 2% entered the workforce, and 2% chose a gap year. The remaining students are still preparing to take steps toward their postsecondary and career goals. In total, 81% of active participants are now enrolled in higher education or training, employed, or enlisted in the military.

"I've never been a big fan of school, so I just assumed my options after high school were pretty limited. College isn't for me but I had no idea what else was out there. Then I found Xcelerate. I've met people with legit jobs that don't require college, jobs I didn't even know existed. Now I know I have options—and that feels real good."

Starting in the 2025–26 school year, we will unify the strengths of our Focused Futures and Xcelerate programs into a single, student-centered program.

Fund Your Next Initiative: This initiative supported 222 SMUSD students—

many of whom would not have applied without direct assistance—in completing their FAFSA or CADAA applications, exceeding our target of 200. An additional 32 students met with the Financial Aid Coach but ultimately chose not to apply. Each was referred to a Career Coach for continued support with postsecondary planning and identifying alternative next steps.

The Sing Me a Story Foundation exists to give children in need the opportunity to share their imagination and creativity with the world through original stories and music. We believe the greatest gift we can give a child is the opportunity to give something of their own — and every child, regardless of circumstance, possesses the power of imagination. Our mission is rooted in the conviction that creativity fosters empathy, builds community, and reminds us all of the humanity we share.

Our programs connect children with songwriters, composers, student musicians, and music therapists to bring their stories to life as original pieces of music. These stories are not simply translated into songs — they are given a platform and an audience, making the child's voice heard, valued, and celebrated. We create experiences that empower children, inspire musicians, and unite communities around moments of shared creativity.

Core Programs

1. **Story-to-Song Program** – Volunteer songwriters from around the world choose a story from our website, written by a child served by one of our nonprofit partners. They transform it into a song and we send it back to the child and their family.
2. **Composition Program** – Launched in 2021, the Composition Program connects a child in need — often facing a significant health diagnosis or life challenge — with a student composer from a local university and a school music ensemble (band, choir, or orchestra). The composer writes a new piece of music inspired by the child's story, tailored to the ensemble's strengths. The work is premiered at a public concert attended by the child, their family, and the broader community.
3. **SMAS Inner Circle** – The SMAS Inner Circle is a group of volunteer professional music therapists who are especially talented, compassionate, and trustworthy. Often recommended by peers or connected through inquiry, these therapists are entrusted with our most delicate stories. While nothing replaces the attention of a music therapist on site, the Inner Circle helps bring a small fraction of these therapeutic services to families who might not otherwise have access. Their work blends clinical sensitivity with creative expression, ensuring that some of our most vulnerable storytellers are supported by professionals uniquely equipped to meet them with artistry and care. Through this program, we also advocate for the critical work of music therapists and highlight the need for more on-site positions at our partner organizations.

Strategic Objectives

- **Empower Children in Need** – Provide children facing adversity with a joyful, public platform to share their imagination.
- **Enhance Arts Education** – Offer student musicians unique opportunities to premiere new works, collaborate with composers, and connect with the human stories behind the music.
- **Foster Community Connections** – Bring together nonprofits, schools, musicians, families, and audiences in shared experiences that celebrate creativity and empathy.

Milestone Achievements in San Marcos

In 2024, we partnered with the **San Elijo Middle School Band** and the **Emilio Nares Foundation** to celebrate the story of a local child who had survived cancer. That child's imaginative story became the inspiration for a new musical composition written specifically for the San Elijo Middle School Band. Students rehearsed for weeks, learning not just the notes but also the courage and creativity behind the piece. At the premiere concert, the child and their family sat in the audience surrounded by classmates, teachers, and neighbors — a shared celebration of resilience and imagination that brought the community together.

This project reached hundreds of San Marcos residents in person and many more online through the summary video, which captured the journey from imagination to performance.

2. **Student Musicians and Composers** – San Elijo Middle School students experienced the excitement of performing a world premiere and connecting with the human story behind their music. Composers gain valuable experience creating work with deep personal significance.
3. **The Broader Community** – The concert became a true community event, drawing residents together to celebrate resilience, creativity, and connection.

Measurement and Evaluation

We measure impact using both quantitative and qualitative methods:

- **Quantitative:** Number of participants (child, composer, student musicians, educators), concert attendance, views of the summary video, funds raised for the partnering nonprofit, and media reach.
- **Qualitative:** Feedback from the child and their family, participating

musicians, educators, nonprofit partners, and audience members.

Sing Me a Story is more than an arts program — it is a community-building, empathy-growing, joy-sharing experience. Since starting our chapter in 2016, our Keystone program has served over 2,000 families in San Diego County, yet 150 families remain on the waiting list.

Our goal is to expand access to our health, education and respite programs. These programs include peer-to-peer support for veterans and caregivers and family events, such as Movie Nights, retreats, picnics, and tickets to family attractions. **We are requesting \$10,000 to serve 200 additional families in San Marcos.**

Yellow Ribbon Fund's Mission and Community Impact

Yellow Ribbon Fund, a nonprofit 501(c)(3), is a national veteran service organization dedicated to keeping the family together during the critical recuperation phase when an ill or wounded Veteran returns home from service. Founded in 2005 for post-9/11 critically injured veterans and their families, Yellow Ribbon Fund's mission is to provide supplemental assistance to wounded, ill and injured service members and their caregivers -- bridging the gap between their needs and earned benefits -- enabling families to stay together during critical recuperation.

Yellow Ribbon Fund is comprised of two programs, Crossroads and Keystone, and we make an impact on veterans and their families nationwide. Across both programs, we have served more than 2,500 families in our Crossroads Program and more than 5,400 veterans and caregivers in our Keystone Program, across eight states including: California, Colorado, North Carolina, Texas, Florida, Kentucky/Tennessee, Washington, D.C, Maryland, and our National Virtual chapter.

While Crossroads provides temporary housing with nine private apartments, hotel partnerships and rental car transportation to enable families to stay close to their wounded veterans under care at Walter Reed National Medical Center, this temporary housing eases their financial burden of paying for housing and bills back home. More importantly, Crossroads keeps families together, providing added moral and emotional support for the recuperating Veteran.

Our Keystone program has 11 Keystone chapters in eight states that offers health, wellness, education, fitness, nutritional awareness, respite and family events for Veterans and their families. Located in California, Colorado, Florida, Kentucky/Tennessee, Texas, Washington, D.C./Maryland and North Carolina, we served 5,400 veteran families this past year.

Strategic Objectives

First and foremost, our objective is to increase access for our veteran

families so that they can participate and benefit from Yellow Ribbon Fund's programs and services. Our goal is to increase recipient engagement by 50% a year to ensure that every veteran family can access our services. We will accomplish this goal through our strong network of community supporters who collaborate with us to provide mental health, nutritional awareness, fitness and respite programs that foster participation among the surrounding U.S. military communities.

Our second objective is to help veterans and caregivers achieve financial literacy. Many service families are living at or near the Federal Poverty Level as a result of living on single, fixed incomes. Caregivers have had to give up their jobs to care for their their wounded spouses with weekly doctors' and therapy appointments. Yellow Ribbon Fund teaches veterans and caregivers how to manage a budget, balance a checkbook, pay off their debt and save for the future, whether it's buying a house or paying for college. These financial literacy classes are not only helping to provide financial stability, but they're also helping families regain peace of mind that relieves some of the mental anguish many of these families have faced since their loved ones came back from serving overseas.

Our third objective is to keep families together. As these heroes recuperate, every one in the family feels the emotional and physical stress of a different family dynamic when a wounded loved one returns home with long-term care needs for recuperation. That is why Yellow Ribbon Fund believes in the healing power of respite programs for these families. Events including picnics, retreats, "Movie Nights" and special theme park trips are vital in keeping these families together. These events promote peer-to-peer support in relaxed settings among veterans, caregivers and kids. Grants, such as the San Marcos Community Grant, make it possible for these families to forget about their troubles, escape from all the stressful doctors' appointments and find a little fun, creating lasting memories that these families will never forget.

With each of these objectives, Yellow Ribbon Fund is committed to continuous improvement and adapting to changing community needs through quantitative and qualitative analysis. We survey our veteran families after every event to measure their engagement in the program. Their responsiveness ensures that we remain relevant and impactful in our efforts to support veterans and caregivers.

Milestone Achievements

Yellow Ribbon Fund is proud to share some of the outstanding achievements made among our San Marcos and San Diego County service families:

The Jackson family's daughter is a recent graduate of California State University San Marcos and is now a teacher in Los Angeles.

The Surla family started their own successful food truck business, while the Gomez-Munguia family started their own beekeeping business in San Diego and their daughter graduated at the top of her class as a welder.

Many of our veteran families (21 families in 2024) have purchased homes,

and are living with financial stability, as a result of learning financial management skills through YRF's Financial Literacy program.

Nicole Heffel, daughter of a service family, is a successful attorney.

Veteran caregiver and wife Brittany Everett went back to school, and she is now a nurse at Rady's Children's Hospital in San Diego, and her husband is doing well in college.

The Yorks, both veterans who completed Yellow Ribbon Fund's financial literacy program, now work as full time civilian contractors at Naval Base San Diego.

The South family is doing well, despite suffering a traumatic injury while serving in Iraq. She's is a longtime high school administrator and her recently got a veteran husband is now an environmental biologist that allows him to be outside, which is very therapeutic as he continues to recuperate.

After making a full recovery, the Jolimeau's, a husband and wife team, both went to trade school and are now working as a cosmetologist and a barber. Their son was accepted to a college out of state and is doing well in his studies. They benefited from Yellow Ribbon Fund's retreats and movie nights that provided memorable escapes that the entire family could enjoy.

Veteran Eddie Robinson recently finished EMT school and is now working towards becoming a firefighter in San Diego County.
